Dear Senators and Representatives:

By now you are aware of The Honorable Mo Brooks' letter calling for a floor debate on various states' electoral college vote submissions, in which Rep. Brooks called for a thorough investigation into the extensive voter fraud, illegal voting, and election theft reported in the weeks subsequent to the November 3rd election.

We write this letter to voice our strong support for Rep. Brooks' call for the investigations into the widespread election irregularities, and to commend Rep. DesJarlais for voicing his support for Rep. Brooks on his initial letter. We also fully support the efforts of Congressman Louie Gohmert to establish the Constitutional duty of the Vice President of the United States, acting as President of the Senate to accept only legitimate electors selected in accordance with and consistent with Article 1, Section 4; Article 2, Section 1, Clause 2 and the Twelfth Amendment to the US Constitution.

Fair elections, free from foreign and outside interference, and fraudulent actions by State officials in violation of state law are pivotal to the survival of our republic, which exists based on the consent of the governed. If our elections cannot be trusted, the republic will no longer enjoy the consent of the governed.

As Rep. Brooks writes, "There are countless incontestable examples wherein governors, election officials, and judges altered states' election procedures in violation of the Constitution's Election Clause, in conflict with Congressional acts setting the times, places and manner of elections, and in conflict with legislative acts similarly setting the times, places and manner of elections. What is unknown is the exact extent to which these violations of Article I, Section 4 illegally affected and altered federal elections within various states.

The election fraud is widespread, and the types of fraud and irregularities are numerous. There are numerous instances of outright voter fraud in four states: Arizona, Georgia, Nevada, and Wisconsin.

- **Ballots were accepted without postmarks, or with backdated postmarks**
- **The U.S.P.S. was alleged to have backdated as many as 100,000 ballots in Wisconsin**
- **Ballots were mishandled in five key states: Georgia, Michigan, Nevada, Pennsylvania, and Wisconsin**
- **In Wisconsin and Michigan, poll workers were observed running ballots through tabulation machines as many as eight or nine times**
- **There are Equal Protection Clause Violations in every single of the six contested states**
- **There are voting Machine Irregularities in five states: Arizona, Georgia, Michigan, Nevada, and Pennsylvania**
- **And there are Significant Statistical Anomalies in five states: Arizona, Georgia, Michigan, Nevada, and Wisconsin**
- **The alleged Biden victory margin in Nevada is 33,596 votes yet the number of ballots in question is more than three times that**
- **In Nevada, progressive socialists Democrats appear to have targeted Native Americans facing severe economic conditions and shamelessly enticed this vulnerable group to trade their votes for Visa gift cards and jewelry.**
- **In Arizona, there are 75,000 lost or destroyed absentee ballots which were improperly tabulated.**
- **More than 70,000 allegedly ineligible voters in Georgia cast ballots there.**
- **One lawsuit claims approximately 15,000 mail-in or absentee ballots were cast in Nevada by voters who were known to have voted in other states.**

Yet very few of these irregularities have been investigated in a professional manner by anyone in law enforcement or in a position to do anything about it. In fact, most of these jurisdictions, save Arizona, are blocking transparency efforts at every turn.

Our nation's judiciary has sadly shown cowardice and refused to listen to the many claims of impropriety, and as such, has not availed itself of the opportunity to judge the evidence of the numerous such cases on their merits. Given this, it is up to the Congress to offer a venue in which a proper, thorough hearing can take place.

Accordingly, we the undersigned hereby call on the Tennessee federal delegation, including Senators Blackburn and Hagerty, to stand with Mo Brooks, Congressman Louie Gohmert, Senator Josh Hawley of Missouri and President Donald Trump as they fight to defend our republic with a full Congressional investigation and vote on electors presented before the Joint Session on January 6th, 2021.

Importantly, this request is not merely an election challenge for President Donald Trump. Indeed, as (3 U.S.C. 15) states, it is Congress's job to either accept or reject the votes presented to it by the electors which comprise the electoral college. Further, as Rep. Brooks writes, "Congress is the final and ultimate judge, jury and arbiter of all contested Congressional, Senatorial, and Presidential elections." The law of the land in the United States has, until recently, been our Constitution. What limits on governmental power truly exist if governments may exceed those limits placed by our Constitution with impunity?

It is with these laws and their continuation in mind that we, the undersigned, ask you on January 6th to vocally support the rule of law, transparent government by joining Rep. Brooks in objecting to the contested electors from those states where Republicans have offered opposing slates of electors. Tennessee, your nation, and your President deserve to have the evidence of widespread fraud and irregularities heard on January 6th. We look forward to your prompt action on these matters that are critical to America's continued existence as a republic.
