This contract is being entered into by Clinch-Powell Educational Cooperative AND The Campbell County School System School Term 2022-2023

This agreement is made and entered into by and between the Campbell County School Nutrition Program and the Clinch-Powell Educational Cooperative (CPEC). Whereas the facilities of the CPEC Head Start Centers are not equipped for preparing and serving meals to children and the facilities of the County's School Nutrition Program are equipped for preparing and serving meals to children from the institution, the supportive County School Nutrition Program agrees to supply meals inclusive of milk to the CPEC Head Start Centers with and for the rates described below.

The following schools will provide the meals for the corresponding Head Start Centers:

School	Head Start Center
Elk Valley Elementary School	Eik Valley Head Start Center
Valley View Elementary	Valley View Head Start Center
West Lafollette Elementary	West Lafollette Head Start Center

The rates for meal reimbursement for the Head Start Program are as follows:

Adult Lunch	\$3.50

Payment, in the form of a check, will be issued monthly to each respective school serving blend Start children. It is further agreed that each meal served will meet the minimum requirements as to nutritive value and content. Each school nutrition office will maintain full and accurate records that the institution will need to meet its responsibility, including the following:

- More records, including amount of food prepared
- Meak, including daily number of meals delivered by type

The meal count records must be agreed upon by the cafetoria manager and the CPEC representative and reported to the institution promptly at the end of the month. The menu records will be available at each school site (cafetoria managers' office). Each school autrition office agrees also to retain records required under the preceding closes for a period of three years after the end of the flocal year to which they pertain, or longer if so audit is in progress. Upon request at a reasonable time and place, all records will be made available to administering agencies and the general accounting office for audit or administrative review.

This agreement shall be effective as of August 1st 2021. It may be terminated by actice in writing by any given party to the other party at least sixty days prior to the date of termination. In Witness thereof, the parties hereto have executed this agreement as of the dates indicated below.

- IV. The Parties agree this Agreement creates an independent contractor relationship, not an employment relationship. Employee benefits will not be provided.
