COMPLAINT								

Comes now, the Plaintiff, Jimmy Trammell, and would show unto the Court the following:

- 1. The Plaintiff is and at all times mentioned herein was a citizen and resident of Campbell County, Tennessee.
- 2. The Defendant, Campbell County Government a/k/a Campbell County, (hereinafter "Campbell County"), is and at all times mentioned herein was a governmental entity. Process with regard to the Defendant, Campbell County, may be served on its managing agent and Mayor, Jack Lynch, 570 Main Street, Jacksboro, Tennessee 37757, pursuant to Rule 4 of the *Tennessee Rules of Civil Procedure*.

The Defendant, Campbell County Board of Education, (hereinafter "Board of Education"), is and at all times mentioned herein was a governmental entity in charge of educational affairs of Campbell County, Tennessee. Process with regard to the Defendant, Campbell County Board of Education; may be served on its managing agent and Director of Schools, Jennifer Fields, at 172 Valley Street, Jacksboro, Tennessee 37757.

- 3. This cause of action is brought pursuant to Tenn. Code Ann. 10-7-501, et seq.¹ Pursuant to Tenn. Code Ann. §10-7-501(b), this Honorable Court has subject-matter jurisdiction over this proceeding. Moreover, venue is proper inasmuch as the Plaintiff is a citizen and resident of Campbell County, Tennessee, and the records sought herein are from Campbell County and Campbell County Board of Education.
- 4. The Plaintiff would show unto the Court that the Plaintiff submitted two (2) Public Records Requests pursuant to Tennessee Public Records Act (TPRA). One said Request was sent to Campbell County Government on December 1, 2022, and one said Request was sent to Campbell County Board of Education on December 1, 2022.²
- 5. That the Request sent to Campbell County Government as set forth herein has not been complied with and no information or communication has been forthcoming. The Plaintiff would show unto the Court that more than thirty (30) days have now elapsed since the Request has been made for which there is no response, and accordingly, it can reasonably be discerned that Campbell County has failed and refused to provide said information, which the Plaintiff would submit is subject to disclosure, pursuant to the Requests as set forth herein.
- 6. The Plaintiff would show unto the Court that in response to the Request sent to Campbell County Board of Education, the Plaintiff received electronic correspondence from the Director of Schools, Jennifer Fields, dated December 16, 2022, indicating that the Request needs to be sent to the attorney for the Board of Education.
- 7. The Plaintiff responded to said electronic correspondence by correspondence dated December 20, 2022, contesting the propriety of the Request set forth in Jennifer Field's email of

December 6, 2022, but nonetheless, forwarded the Request to attorney for the Board of Education, Dail Cantrell.

- 8. On January 3, 2023, the Plaintiff received correspondence from Dail Cantrell,⁴ wherein the information set forth in the Request was still not forthcoming.
- 9. The Plaintiff would show unto the Court that as of the date of the filing of this action, the Plaintiff has neither received this information from Campbell County nor has the Plaintiff received this information from the Board of Education.
- 10. The Plaintiff would show unto the Court that the Campbell County School System has been out of compliance with the State of Tennessee's requirement as it pertains to the health insurance offerings for Board of Education employees. The Plaintiff would show unto the Court that the State of Tennessee required that all school employees, both certified and non-certified, be offered the same health insurance, state-sponsored plan. Contrary to the requirement of the State of Tennessee, Campbell County Board of Education and Campbell County Government failed to comply for several years resulting in significant damages to the employees, not only monetary, but also medical benefits. Hence, the Plaintiff would show unto the Court that there is compelling need for prompt release of the information sought pursuant to said Requests.
- 11. The information sought in the Requests as set forth herein would be essential inasmuch as the Plaintiff was an employee of the Campbell County Board of Education and Campbell County Government for several years until the termination of his employment on or about April 16, 2020.

WHEREFORE, for the foregoing reasons, the Plaintiff demands:

That proper process issue and be served upon the Defendants, and that the 1. Defendants be required to answer this Complaint within the time required by law, but not under oath, its oath being waived.

2. That pursuant to Tenn. Code Ann. §10-7-505(c), the Defendants have failed to meet their burden of proof for justification of nondisclosure of the records sought by the Plaintiff.

That pursuant to Tenn. Code Ann. §10-7-505(d), the Court make a written Finding 3. of Fact and Conclusion of Law and exercise its power of full injunctive remedies.

4. That pursuant to Tenn. Code Ann. §10-7-505(g), the Court finds that the Defendants have willfully failed and refused to make disclosures, and accordingly, assess all reasonable costs, including, but not limited to, attorney fees, against the Defendants for failure to disclose the information sought by the Plaintiff as set forth herein.

5. That pursuant to Tenn. Code Ann. §50-7-505, that the Court enter a judgment in favor of the Plaintiff and order that the records sought by the Plaintiff be made available by the Defendants.

The Plaintiff would further request such further and general relief to which he may 6. be entitled to under the law and evidence.
