Chairman Lasley stated CCHS football was the largest sport in the county. \$5,000 for the track coach at CCHS is divided up among whoever they have helping. About every sport we have could use an assistant. Coach Matt Price stated he thinks the supplement pool is a good thing and other districts like how we do that. Board member Lester asked, "so what are we proposing"? Athletic Chairman Lasley stated He felt they were trying t come up with how many coaches we have from the levels of elementary to high school and how we can increase the supplement across the board. Assistants need an increase as well. Coach Price stated the pool is good because you can adjust the pay according to what someone does to help assist the coach. Chairman Lasley asked what are we paying now? Board member James stated that currently for all supplements would be \$190,000. Bord member Byrge pointed out that major sport head coaches get an extra month. Board member James stated if you've got a school system good in athletics, you'll have good academics. They go hand-in-hand. The athletic committee recommended an allotment of \$350,000.00 be included in the 2023-2024 school year budget for county-wide coaching supplements.
